**TRADEMARK RELEASE**

TRADEMARK RELEASE, effective as of this <sup>28<sup>th</sup></sup> day of March, 2008, given by CITICORP NORTH AMERICA, INC., as Collateral Agent (“Agent”) with principal offices at 290 Greenwich Street, New York, NY 10013, to Intertape Polymer Corp., a Delaware corporation, successor by merger to INTERNATIONAL CONTAINER SYSTEMS, INC., a Florida corporation (“Grantor”), with principal offices at 3647 Cortez Road West, Bradenton, FL 34210, as follows:


