TRADEMARK RELEASE

THIS TRADEMARK RELEASE is made this 27th day of March, 2008, by LIGHTHOUSE FINANCIAL CORP., a North Carolina corporation (the "Secured Party") in favor of CAROLINA NAIL, INC., a North Carolina corporation (the "Grantor");

WITNESSETH:

WHEREAS, on May 21, 1999, the Grantor and the Secured Party executed a Trademark Security Agreement (the "Security Agreement"), which was recorded on June 21, 1999 at Reel 001918, Frame 0627, in the United States Patent and Trademark Office, pursuant to which the Grantor granted the Secured Party a lien in and security interest upon a certain trademark of the Grantor as more particularly described in Exhibit A attached hereto (the "Released Trademark"); and

WHEREAS, the Secured Party, at the request of the Grantor, has agreed to release and terminate its lien in and security interest upon the Released Trademark;

NOW THEREFORE, in consideration of the premises, and for other good and valuable consideration, the receipt and sufficiency of which are hereby expressly acknowledged, the Secured Party hereby releases, discharges and terminates its lien in and security interest upon the Released Trademark, and transfers and conveys to the Grantor all of the Secured Party's right, title and interest in the Released Trademark and the goodwill associated therewith.

This Trademark Release shall be binding upon the Secured Party and its successors and assigns.

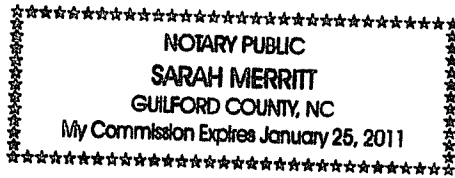
