TRADEMARK RELEASE OF SECURITY INTEREST
(CANADA)

THIS TRADEMARK RELEASE OF SECURITY INTEREST is made as of March 28, 2008, by GE CANADA FINANCE HOLDING COMPANY, as assignee of Merrill Lynch Capital Canada, Inc., as Administrative Agent ("Canadian Agent").

W I T N E S S E T H:

WHEREAS, Canadian Agent and Norwesco Canada Ltd. ("Canadian Company"), were parties to that certain Trademark Security Agreement (Canada) dated as of September 2, 2005 (the "Security Agreement"; capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Security Agreement), pursuant to which Canadian Company granted a security interest to Canadian Agent in, among other things, the Trademarks as security for certain obligations owing by Canadian Company to the financial institutions (collectively, the "Lenders") from time to time party to that certain Credit Agreement by and among, inter alia, Canadian Company, Canadian Agent and Lenders, as amended, restated, supplemented or otherwise modified and in effect from time to time, including the Trademarks set forth on Schedule I hereto; and

WHEREAS, the Security Agreement was recorded by the Assignment Division of the United States Patent and Trademark Office on September 13, 2005 at Reel 003158, Frame 0523; and

WHEREAS, Canadian Company has requested that Canadian Agent release its security interest in the Trademarks and reassign the same to Canadian Company;

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Canadian Agent hereby releases its security interest in all of Canadian Company's right, title and interest in and to all of the following (the "Trademark Collateral");

(a) each Trademark listed on Schedule 1 annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and

(b) all products and proceeds of the forgoing, including without limitation, any claim by Canadian Company against third parties for past, present or future (i) infringement or dilution of any Trademark, or (ii) injury to the goodwill associated with any Trademark.

2. Canadian Agent hereby reassigns, grants and conveys to Canadian Company, without any representation, warranty, recourse or undertaking by Canadian Agent, all of Canadian Agent's right, title and interest in and to the Trademark Collateral, and the goodwill of Canadian Company's business connected with the use of and symbolized by the Trademark Collateral.


