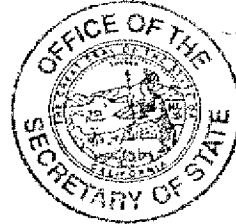

This Agreement of Merger is entered into on this 23rd day of August, 2007 (the "Merger Agreement") between Micronomics, LLC, a California limited liability company (the "Merging Entity"), and RW Economics, Inc., a California corporation (the "Surviving Corporation").

WHEREAS, the Surviving Corporation is the holder of 100% of the outstanding units of membership interests of the Merging Entity;

WHEREAS, Roy Weinstein, as sole director and sole shareholder of the Surviving Corporation has approved the Merger Agreement, the merger contemplated hereunder and the Name Change;

WHEREAS, the Merging Entity is managed by its members and the Surviving Corporation is the sole member of the Merging Entity; and

WHEREAS, the Surviving Corporation, as sole member of the Merging Entity has approved the Merger Agreement and the merger contemplated hereunder.

NOW, THEREFORE, the Merging Entity and the Surviving Corporation hereby agree as follows:


1. The Merging Entity shall be merged with and into Surviving Corporation (the "Merger").
2. The Merger shall be effective as of the effective date of the Merger, as prescribed by law (the "Effective Date").
3. Upon the Effective Date, each outstanding unit of membership interests of the Merging Entity shall be canceled without consideration.
4. Upon the Effective Date, each outstanding share of common stock of the Surviving Corporation shall remain outstanding and shall not be affected by the Merger.
5. Upon the Effective Date, the Surviving Corporation shall change its name to "Micronomics, Inc." (the "Name Change").
6. The Merging Entity shall from time to time, as and when requested by the Surviving Corporation, execute and deliver all such documents and

instruments and take all such actions necessary or desirable to evidence or carry out the Merger.


7. This Merger Agreement may be executed in any number of counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.


