WHEREAS, Assignor desires to assign to Assignee all right, title and interest in and to the Trademarks.


NOW, THEREFORE, Assignor makes the following assignment:

**Assignment.** Assignor hereby assigns, transfers, and conveys, as of the Effective Date, all of Assignor's right, title and interest in and to the Trademarks.


**Consideration.** In exchange for the Assignment, Assignee hereby agrees to pay to Assignor the sum of One Dollar (\$1.00).
