WHEREAS, Assignor owns a number of trademark registrations and applications for registration relating to its shoe business, as listed in the attached Schedule A; and



2. At the request of the Assignee, Assignor will execute, acknowledge and deliver, without additional cost, such additional instruments of assignment as may be reasonably necessary to establish and perfect the ownership of record of all trademark rights transferred under this Assignment.

IN WITNESS WHEREOF, Assignor has caused this Assignment to be duly executed by its authorized representative as of the date first above written.


