RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST (this "Release") is executed as of this 31st day of March, 2008, by Citibank, N.A., as Administrative Agent (in such capacity, the "Administrative Agent").

WHEREAS, PowerSecure International, Inc., a Delaware corporation (the "Borrower"), the Administrative Agent and the other lending institutions which are or may from time to time become signatories thereto or any successor or assignee thereof (collectively, the "Revolving Lenders") entered into that certain Credit Agreement dated as of August 23, 2007 (as amended, modified, supplemented or restated, the "Revolving Credit Agreement") and Borrower, the Administrative Agent and the other lending institutions which are or may from time to time become signatories thereto or any successor or assignee thereof (collectively, the "Term Lenders", together with the Revolving Lenders, the "Lenders") entered into that certain Term Credit Agreement dated as of January 17, 2008 (as amended, modified, supplemented or restated, the "Term Credit Agreement", together with the Revolving Credit Agreement, the "Credit Agreement");

WHEREAS, in connection with the Credit Agreement, Metrotek, Incorporated, a Florida corporation ("Metrotek") executed that certain Security Agreement dated as of August 23, 2007, in favor of the Administrative Agent for the benefit of the Lenders, as amended by the First Amendment to Security Agreement dated as of January 17, 2008 (the "Security Agreement");

WHEREAS, pursuant to the terms and conditions of the Security Agreement, the Administrative Agent for the benefit of the Lenders was granted a security interest in, among other things, all of Metrotek's interest in the collateral more specifically described on Exhibit A attached hereto ("Collateral").

WHEREAS, the Security Agreement was filed with the United States Patent and Trademark Office on September 21, 2007, and recorded against the Collateral on Reel 003625, Frame 0743.

WHEREAS, the Administrative Agent has received consideration for a full and complete release of the security interest in and liens in the Collateral, and now wishes to release such security interest and liens in the Collateral.

NOW THEREFORE, the Administrative Agent, on its own behalf and on behalf of the Lenders, hereby releases, cancels and terminates all of its right, title and interest in and to the Collateral, including its security interest in and liens on the Collateral and all other rights with respect to the Collateral, and conveys and assigns any and all right, title and interest that it may have in and to the Collateral to Metrotek.

IN WITNESS WHEREOF, the Administrative Agent has caused this Release to be duly executed by its officer thereunto duly authorized as of the date hereof.

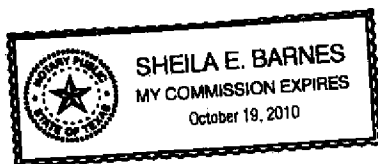
