ASSIGNMENT OF TRADEMARK

Agreement made as of the 2nd day of April, 2008, by and between Delilah Media Group, L.P., a Texas Limited Partnership, and Delilah Rene, an individual ("Assignor"), and Big Shoes Production, Inc., a Washington corporation ("Assignee").

Recitals

WHEREAS, Assignor is the owner of the trademark/service mark DELILAH and U.S Trademark Application Serial No. 75/285469 and Registration No. 2149463 for entertainment services in the nature of on-going radio programs in the field of variety in International Class 41 (hereinafter the DELILAH Registration);

WHEREAS, Assignee is the successor-in-interest of Assignor in said business; and

WHEREAS, Assignor and Assignee desire to transfer all of Assignor's rights and ownership in the DELILAH Mark and the DELILAH Registration, together with the goodwill appurtenant thereto, to Assignee.


Terms and Conditions

1. Assignments. Assignor hereby transfers and assigns to Assignee all of its rights, title and interest in the DELILAH Mark, and goodwill appurtenant thereto, and to the application therefor and registration thereof. Assignor hereby transfers and assigns to Assignee all its rights, title and interest in the DELILAH Registration, and goodwill appurtenant thereto.
2. Ownership. Assignor acknowledges Assignee's exclusive rights, title and interests in the DELILAH Mark, and the application therefor and registration thereof, and will not at any time do or cause to be done any act contesting or in any way impairing or tending to impair such rights, title and interests or full exercise thereof.
3. Successors and Assigns. Assignor and Assignee agree that this Assignment shall be binding upon their respective successors, assigns, attorneys, representatives, officers, directors, shareholders, servants, agents, employees, insurance companies, bonding companies, sureties, subsidiaries and affiliates.
4. Choice of Law. If any action is commenced to enforce or interpret any of the provisions of this Assignment, Assignor and Assignee hereby agree that this Assignment shall be interpreted, enforced and governed by the laws of the State of Washington. Assignor and Assignee agree that any action to enforce this Assignment, or any rights granted herein, must be brought in a court having its situs within King County, Washington, and no other court.
5. Amendments. This Assignment may be amended only by written instrument executed by Assignor and Assignee.




