TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT, effective as of the 31st day of January, 2007, by Horner-Galleher Holding Company, Inc. (n/k/a Half Moon Beach Holding Company), a Maryland corporation ("Half Moon"), Galleher, Inc. (n/k/a Ramah Corp.), a California corporation ("Ramah"), and Hamar Wood Parquet Company (n/k/a Calumet Ave. Partners), a California corporation (together with Half Moon and Ramah, the "Assignors"), to Galleher Corporation (f/k/a Galleher Acquisition Corp.), a Delaware corporation ("Assignee"). Capitalized terms used but not defined herein shall have the meaning assigned to them in the Purchase Agreement (defined below).

RECITALS

WHEREAS, Assignee and Assignors are parties to an Asset Purchase Agreement dated as January 31, 2007 (the "Purchase Agreement"), pursuant to which Assignors have agreed to sell to Assignee and Assignee has agreed to buy from Assignors the Assets, including without limitation, the Intellectual Property used or held for use in the Business, including the trademarks set forth on Schedule A attached hereto (the "Marks").

WHEREAS, pursuant to the Purchase Agreement, Assignors have agreed to execute such instruments as the Assignee may reasonably request in order to more effectively assign, transfer, grant, convey, assure and confirm to Assignee and its successors and assigns, or to aid and assist in the collection of or reducing to possession by the Assignee of the Assets.

WHEREAS, it is desired that the assignment of said Marks, and registrations and applications therefore, be made of record in the United States Patent and Trademark Office, and other appropriate Patent and Trademark Offices.


