## TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (this "Assignment"), effective the 20th day of March, 2008 (the "Effective Date"), is made and entered into by and between DR. MIRACLE'S, L.L.C., a New York limited liability company, having a principal place of business at 183 Madison Avenue, Suite 405, New York, New York 10016, and DR. WONDER, L.L.C., a New York limited liability company and wholly owned subsidiary of Dr. Miracles L.L.C., (collectively the "Assignors"), and DR. MIRACLES, INC., a Delaware corporation, having a principal place of business at 7 Greenwich Office Park, Suite 200 599 West Putnam Avenue, Greenwich, CT 06830, ("Assignee") (each a "Party," and collectively, the "Parties"). Capitalized terms used in this Assignment but not otherwise defined herein shall have the meanings set forth in the Asset Contribution Agreement (defined below). Assignors and Assignee may be collectively referred to herein as the "Parties."

WHEREAS, Assignors are the owners of certain rights, title and interest in and to the Transferred Trademarks (as defined below);

WHEREAS, the Assignors and Assignee entered into that certain Asset Contribution Agreement dated March 20, 2008, by and among Assignors, Assignee, Brian K. Marks, Richard Lombardi, Ollie Johnson, Rabiadou Marks, Ethnic Brands LLC, a Delaware limited liability company, and DRM Holdings, Inc., a Delaware corporation (the "Asset Contribution Agreement"), pursuant to which Assignee purchased, among other things, all the Acquired Assets of the Assignors, including the Transferred Trademarks from the Assignors;

WHEREAS, pursuant to the terms of this Assignment, and in consideration of the performance by Assignors of their obligations under the Asset Contribution Agreement and in order to satisfy those obligations, each of the Assignors desires to transfer to Assignee, and Assignee desires to accept, all of Assignors' right, title and interest in and to the Transferred Trademarks, together with the goodwill associated therewith; and

WHEREAS, the execution and delivery of this Assignment is a condition to Closing.

NOW THEREFORE, for the consideration set forth in the Asset Contribution Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. Assignment. All Assignors hereby assign to Assignee all of Assignors' right, title and interest in and to the following (collectively, the "Transferred Trademarks"): trade names, trademarks and service marks (registered and unregistered anywhere in the world), domain names and other Internet addresses or identifiers, trade dress and similar rights and applications), including but not limited those items set forth on Schedule A hereto; and intent to use applications to register any of the foregoing, including, without limitation, the name "Dr. Miracle's", and "Dr. Wonder" and the goodwill associated therewith; together with all rights therein provided by international conventions and treaties, and the right to sue for past, present and future infringement thereof. The parties acknowledge and agree that the transfer of any U.S.



Intent-to-Use applications hereunder is in connection with the sale of the ongoing and existing Business to which they pertain.

2. No Warranties. Except as expressly provided in the Asset Contribution Agreement, Assignors make no warranties, express or implied, with respect to the Transferred Trademarks. Without limiting the generality of the foregoing, Assignors expressly disclaim any such warranties as to the nature or extent of Assignors' right, title or interest in and to the unregistered trademarks transferred hereby, or as to the registrability of such trademarks.

3. Further Assurances and Authorizations. Assignors shall, at the request, cost and expense of Assignee, timely execute and deliver any additional documents and perform any additional acts necessary or desirable to record and perfect throughout the world the conveyance and transfer under this Assignment of the Assignors' right, title and interest in and to the Transferred Trademarks to Assignee, and shall not enter into any agreement in conflict with this Assignment. Each Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States, and any officer of any country or countries foreign to the United States, whose duty it is to issue service marks, trademarks, copyrights, patents or other evidence or form of intellectual property protection or applications therefor, to issue the same to Assignee and Assignee's successors, assigns and other legal representatives in accordance with the terms of this instrument.


4. Governing Law. This Assignment shall be governed by, and construed in accordance with, the laws of the State of New York, without reference to that state's choice of law provisions. All Actions arising out of or relating to this Assignment shall be heard and determined in accordance with Article 9 of the Asset Contribution Agreement.

5. Counterparts. This Assignment may be executed in one or more counterparts, each of which shall be deemed an original, and all of which together shall constitute one and the same agreement.

6. Liability. The Parties acknowledge and agree that the sole purpose of this Assignment is to satisfy the obligations of the Assignors under the Asset Contribution Agreement relating to the sale of the Transferred Trademarks (the "Relevant Obligations"); that the Asset Contribution Agreement includes negotiated provisions addressing the allocation of liability between the parties to that agreement; that it is the intention of the Assignors and Assignee, and all parties to the Asset Contribution Agreement, that any claims relating to the Relevant Obligations will be brought under the Asset Contribution Agreement between the parties to those agreements and not under this Assignment; and therefore, the Parties shall have no liability to each other under or in connection with this Assignment. Without prejudice to the generality of the foregoing, no Party shall be liable under or in connection with this Assignment for any loss of profits, loss of business, loss of customers, loss of reputation or goodwill, wasted time or any consequential or indirect loss, howsoever arising and whether or not the party concerned was or ought to have been aware of the likelihood of such loss. No party hereunder limits or excludes any liability which it is not allowed to limit or exclude under applicable law.





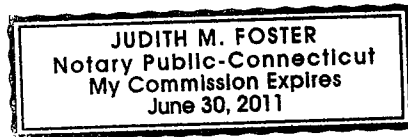
