GENERAL FORM OF RELEASE**

TO: CANSTAR SPORTS INC. ("CSI")
AND TO: CANSTAR SPORTS GROUP INC. ("CSGI")
AND TO: CANSTAR SPORTS U.S.A., INC. ("CANSTAR USA")
AND TO: HELMTEC INDUSTRIES INC. ("Helmtec")

Reference is made to the amended and restated credit agreement made as of June 8, 1988, as amended and restated as of February 1, 1989, as amended as of July 24, 1989, January 31, 1990, December 1, 1990 and April 1, 1991, as further amended and restated as of July 9, 1991, as further amended as of June 26, 1992 and as supplemented as of May 28, 1993, between the several lenders named therein (the "Lenders"), Bank of Boston Canada ("BBC"), as agent for the Lenders, and CSGI, as borrower (the "Credit Agreement") and guaranteed by Canstar USA, CSI and Helmtec. Terms defined in the Credit Agreement and not otherwise defined herein shall have the meanings assigned to them in the Credit Agreement.

In consideration of the sum of \$5.00 paid by each of you to each of the undersigned (the receipt and sufficiency of which are hereby acknowledged by each of the undersigned) and for other good and valuable consideration, each of the undersigned hereby: (i) remises, releases and forever discharges all Liens in favour of the undersigned and all liabilities of you or any of your Affiliates pursuant to the Security Documents (the said Liens and liabilities are collectively referred to herein as the "Security"), and all such Security Documents shall cease to be of any force or effect whatsoever including, without limitation, the Security Documents set out on Exhibit A annexed hereto, and (ii) reassigns, reconveys and retransfers to you, as entitled as among yourselves thereto, any right, title and interest of each of the undersigned in your property, assets and undertaking.

Contemporaneously with the signing of this release or as soon as possible thereafter, each of the undersigned hereby covenants and agrees to deliver to you, at your expense, deeds of discharge in registerable form and in sufficient quantity to effect the registration of the release and discharge of the Security wheresoever required by law, duly executed by the appropriate secured party. Each of the undersigned further covenants and agrees to do such further acts and things and to execute and deliver, at your expense, such further documents and instruments as may be necessary or desirable from time to time to evidence the complete discharge of the Security and the termination of the Security Documents as set forth herein.


