FIRST AMENDMENT TO TRADEMARK SECURITY AGREEMENT

This FIRST AMENDMENT TO TRADEMARK SECURITY AGREEMENT (this "Amendment") is entered into as of March 31, 2008 among the Grantor signatory hereto and LaSalle Bank National Association, as Agent ("Agent") for the financial institutions ("Lenders") from time to time party to the Credit Agreement (as defined below).

WITNESSETH:

WHEREAS, Agent, the Lenders and Grantor are parties to that certain Second Amended and Restated Credit Agreement, dated as of March 22, 2007 (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "Credit Agreement")

WHEREAS, Agent and Grantor are party to that certain Trademark Security Agreement dated as of March 22, 2007 (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "Security Agreement"); and

WHEREAS, the parties hereto desire to amend the Security Agreement as set forth below.

NOW THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each signatory hereby agrees as follows:

1. **Amendment.** The Security Agreement is hereby amended by supplementing Schedule 1 to the Security Agreement to include the information set forth on Exhibit A attached hereto.

2. **Representations and Warranties.** Each Grantor hereby confirms that the representations and warranties set forth in the Security Agreement are true and correct in all material respects as of the date hereof, in each case after giving effect to the amendments herein, with the same effect as though made on the date hereof (except to the extent such representations and warranties expressly refer to an earlier date, in which case they are true and correct in all material respects as of such earlier date).

3. **Governing Law.** This Amendment shall be a contract made under and governed by the internal laws of the State of Illinois.

4. **Counterparts.** This Amendment may be executed in any number of counterparts, and by the parties hereto on the same or separate counterparts, and each such counterpart, when executed and delivered, shall be deemed to be an original, but all such counterparts shall together constitute but one and the same Amendment.
