## NOTICE OF SATISFACTION OF TRADEMARK SECURITY AGREEMENT

THIS NOTICE OF SATISFACTION OF TRADEMARK SECURITY AGREEMENT dated as of March 31, 2008 (this "Notice") is given by WACHOVIA BANK, NATIONAL ASSOCIATION, a national banking association, as Administrative Agent (in such capacity, the "Administrative Agent") for the ratable benefit of the banks and other financial institutions party to the Credit Agreement (as defined below) from time to time (the "Lenders") in favor of (a) COTT CORPORATION, a Canadian Corporation ("Cott") located at 6525 Viscount Road, Mississauga, ON L4V 1H6 and (b) COTT BEVERAGES INC., a Georgia corporation located at 5519 West Idlewild Avenue, Tampa, Florida 33634-8016, for itself and, by merger as successor in interest to Cott Beverages Wyomissing Inc. ("Cott USA" and, together with Cott, the "Grantors").

WHEREAS, pursuant to that certain Credit Agreement dated as of March 31, 2005 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement") by and among Cott, Cott USA, Cott Beverages Limited, a corporation incorporated under the laws of England and Wales, Cott (Nelson) Limited (formerly know as Macaw (Soft Drinks) Limited), a corporation incorporated under the laws of England and Wales and Cott Embotelladores de Mexico, S.A. de C.V., a company organized under the laws of Mexico, as borrowers, the Lenders and the Administrative Agent, (a) Cott entered into certain Trademark Security Agreements dated as of March 31, 2005 and April 8, 2005, and (b) Cott USA entered into certain Trademark Security Agreements, dated as of March 31, 2005, in each case, pursuant to which such Grantor granted to the Administrative Agent a continuing security interest in all of Grantor's rights, title, and interest in, to the trademarks, trademark registrations and trademark applications listed on the attached Schedule A along with all of the goodwill of the business connected with the use of and symbolized by each such trademark, trademark registration and trademark application and other related rights and proceeds, as specified in Trademark Security Agreements (collectively, the "Trademarks"); and

WHEREAS, evidence of the security interest were recorded in the United States Patent and Trademark Office as follows:

June 1, 2005 at trademark reel 3094, frame 0808;

June 1, 2005 at trademark reel 3094, frame 0816; and

June 1, 2005 at trademark reel 3094, frame 0859.

NOW, THEREFORE, the Obligations (as defined in the Credit Agreement) have been satisfied in full and any security interest of the Administrative Agent in the Trademarks has been terminated and released.
