ASSIGNMENT AGREEMENT

This ASSIGNMENT AGREEMENT (this "Assignment") is made and entered into this 6th day of April, 2006 by and between MSNBC Cable L.L.C., a Delaware limited liability company ("Assignor"), MSNBC Marks Trust, a Delaware statutory trust ("Assignee" or "Trust"), and, solely for the purposes of Section 3, Microsoft Corporation, a Washington corporation ("MS") and NBC Universal, Inc., a Delaware corporation ("NBCU").

WHEREAS, Assignor is the owner of the trademarks, trademark registrations, and trademark applications set forth on Schedule A hereto (the "MSNBC Marks");

WHEREAS, Assignor has entered into a Trust Agreement, dated April 6th, 2006, (the "Trust Agreement") establishing the Trust for the purpose of holding and administering the MSNBC Marks;

WHEREAS, Assignor wishes to transfer and assign the MSNBC Marks to the Trust in accordance with the terms and conditions of the Trust Agreement and this Assignment.

NOW THEREFORE, in consideration of the mutual premises herein and in the Trust Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:


1. Assignment. Assignor hereby assigns to Assignee all of Assignor's right, title and interest in and to the MSNBC Marks, including (i) all rights therein provided by international conventions or treaties, (ii) any and all goodwill of the business symbolized by the MSNBC Marks, (iii) all renewals and extensions of registrations thereof that may be secured under the laws of any jurisdiction, and (iv) any and all rights to sue or recover and retain damages and costs and attorneys' fees for past, present and future infringement, dilution, misappropriation, or other violation thereof, and rights of priority and protection of interests therein under the laws of any jurisdiction.

2. No Warranties. Assignor makes no warranties, express or implied, with respect to the MSNBC Marks.


3. Consent; Further Assurances. Assignor shall take all actions and execute all documents necessary or desirable to record and perfect the interest of Assignee in and to the MSNBC Marks, and shall not enter into any agreement in conflict with this Assignment. MS and NBCU consent to the assignment of the MSNBC Marks to the Trust as provided in this Assignment. The costs and expenses incurred by Assignor in order to comply with this Section 3 shall be divided equally between MS and NBCU.


