ARTICLES OF AMENDMENT  
TO THE  
RESTATED ARTICLES OF INCORPORATION  
OF  
SOUTHWEST CAFES, INC.

Pursuant to Article 4.04 of the Texas Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Restated Articles of Incorporation.

ARTICLE 1

The name of the corporation is Southwest Cafes, Inc.

ARTICLE 2

The following amendment to the Restated Articles of Incorporation was adopted by the shareholders of the corporation on October 8, 1992 to change the name of the corporation to "El Chico Restaurants, Inc."

The amendment alters Article One of the Restated Articles of Incorporation. The full text of the provision altered is as follows:

"Article One

The name of the corporation is El Chico Restaurants, Inc."

ARTICLE 3

The number of shares of the corporation outstanding on August 24, 1992, the record date for such adoption, was 4,379,559 shares of the corporation's common stock; the number of shares entitled to vote thereon was 4,379,559 shares of the corporation's common stock.

ARTICLE 4

The number of outstanding shares of the corporation's common stock that voted for the amendment was 3,552,568 shares; that voted against the amendment was 3,470 shares; and that abstained from voting was 80,252 shares.

ARTICLE 5

This amendment does not effect a change in the capital of the corporation.
