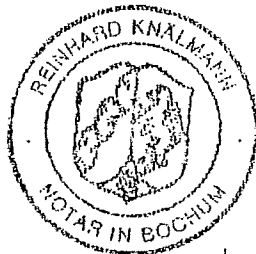


Notary statement
