**TERMINATION AND RELEASE**

**OF SECURITY INTEREST**

**TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (this "Termination and Release") is executed on behalf of Electronic Arts Inc. (the "Secured Party") in favor of Pandemic Studios, LLC, a California limited liability company (the "Debtor").

**RECITALS**

A. Debtor and Secured Party entered into a Security Agreement dated as of October 11, 2007 (the "Security Agreement"). All capitalized terms defined in the Security Agreement are used with the same meanings, unless otherwise defined, in this Termination and Release.

B. Debtor and Secured Party entered into a Grant of Security Interest dated as of October 11, 2007 (the "Agreement"), to secure the payment and performance of the obligations of Debtor as set out in the Security Agreement, which Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office at Reel/Frame 003639/0477, on October 12, 2007.

C. Pursuant to the Agreement, the Debtor pledged and granted to the Secured Party a security interest in all of the Debtor's right, title and interest in and to the Trademarks (as defined in the Agreement), including without limitation the registered trademarks and trademark applications identified on Schedule A attached hereto.

WHEREAS, the Debtor has satisfied all of its obligations under the Security Agreement, and the Secured Party wishes to terminate and release its security interest in the Trademarks, including, without limitation, all of the trademarks and trademark applications identified on Schedule A attached hereto.

NOW, THEREFORE, the Secured Party hereby releases and terminates its security interest in all Trademarks, including, without limitation, all of the trademarks and trademark applications identified on Schedule A attached hereto. The Secured Party hereby agrees that it will execute such further documents as deemed reasonably necessary by the Debtor to effect the terminations and releases described in this Termination and Release. This Termination and Release shall be governed by and construed in accordance with the laws of the State of California.

IN WITNESS WHEREOF, the Secured Party has caused this Termination and Release to be duly executed as of the 31<sup>ST</sup> day of March, 2008.
