This instrument and the rights and obligations evidenced hereby are subordinate in the manner and to the extent set forth in that certain Intercreditor and Subordination Agreement (the "Intercreditor Agreement"), dated on or about April 2, 2008 by and among (i) Sun Hickory Farms Reserves, LLC, a Delaware limited liability corporation, (ii) Hickory Farms, Inc., a Delaware corporation, Hickory Farms Holding Corp., a Delaware corporation, and Canadian Hickory Farms, Ltd., a corporation organized under the laws of the Province of Ontario (collectively, the "Companies"), (iii) PNC Bank, National Association, as agent (the "Revolver Agent"), and (iv) Ableco Finance LLC, as administrative agent and collateral agent (the "Term Loan Agent" and together with the Revolver Agent, being collectively, the "Senior Agents" and each individually a "Senior Agent"), to the indebtedness (including interest) owed by the Companies pursuant to (A) that certain Revolving Credit and Security Agreement dated as of September 28, 2007 by and among Hickory Farms, Inc., the Revolver Agent and the lenders from time to time party thereto (the "Revolving Credit Agreement") and (B) that certain Term Loan and Security Agreement dated as of September 28, 2007 by and among Hickory Farms, Inc., the Term Loan Agent and the lenders from time to time party thereto (the "Term Loan Agreement" and together with the Revolving Credit Agreement, the "Senior Credit Agreements") and related agreements, instruments and documents, as such Senior Credit Agreements and related agreements, instruments and documents have been and hereafter may be amended, supplemented or otherwise modified from time to time and to indebtedness refinancing the indebtedness under that agreement and related agreements, instruments and documents, in each case to the extent permitted by the Intercreditor Agreement; and each holder of this instrument, by its acceptance hereof, irrevocably agrees to be bound by the provisions of the Intercreditor Agreement.

## TRADEMARK SECURITY AGREEMENT

TRADEMARK SECURITY AGREEMENT, dated as of March 24, 2008, by HICKORY FARMS, INC., a Delaware corporation, ("Grantor"), in favor of SUN HICKORY FARMS RESERVES, LLC, a Delaware limited liability company (the "Secured Party").

### WITNESSETH:

WHEREAS, the parties hereto have executed that certain Senior Subordinated Secured Promissory Note dated as of the date hereof (as amended, supplemented, amended and restated or otherwise modified from time to time, the "Note"); and

WHEREAS, the Grantor has executed and delivered to the Secured Party, that certain Security Agreement dated as of the date herewith (as from time to time amended, restated, supplemented or otherwise modified, the "Security Agreement");

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and in order to induce the Secured Party to enter into the Note the Grantor agrees with the Secured Party as follows:

1. DEFINED TERMS. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Note.

2. GRANT OF SECURITY INTEREST IN TRADEMARK COLLATERAL.

Grantor hereby pledges and grants to the Secured Party a lien on and a security interest in and to all of Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter created or acquired (collectively, the "Trademark Collateral"):

- (a) All of its trademarks registrations and trademark applications (provided, that no security interest shall be granted in United States intent-to-use trademark or service mark applications to the extent that and solely during the period in which the grant of a security interest therein would impair the validity or enforceability of such intent-to-use applications under applicable federal law), including those referred to on Schedule I hereto;
- (b) all renewals, registrations, continuations and extensions of the foregoing;
- (c) all goodwill of the business connected with the use of, and symbolized by, the foregoing; and
- (d) all products and proceeds of the foregoing, including, without limitation, any claim by such Grantor against third parties for past, present or future (i) infringement or dilution of any of the foregoing, or (ii) injury to the goodwill associated with any of the foregoing.


