TRADEMARK ASSIGNMENT

WHEREAS, Streamfeeder, LLC, a Minnesota limited liability company (“Streamfeeder”), owns the entire right, title and interest in and to the trademarks U.S. Trademark Registration Nos. 1647886 and 2149900, Canada TMA 500034 and European Community 503086 (collectively, the “Trademark”); and

WHEREAS, Thiele Technologies, Inc., a Missouri corporation (“Thiele”), is desirous of acquiring all of Streamfeeder’s right, title and interest in and to the Trademark, pursuant to the Asset Purchase Agreement, dated of even date herewith, to which Streamfeeder, Thiele and certain others are parties (“Purchase Agreement”).

NOW THEREFORE, in consideration of these premises, the covenants and obligations in the Purchase Agreement, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Streamfeeder hereby sells, assigns and transfers unto Thiele the entire right, title and interest in and to the Trademark and any registration(s) issuing therefrom, together with the goodwill of Streamfeeder’s business associated therewith, and the right to sue for, and recover for, any past infringements thereof, to be held and enjoyed by Thiele, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by Streamfeeder had no sale and assignment of said Trademark been made.

2. Streamfeeder shall, upon the request and at the expense of Thiele, execute any further documents reasonably required by Thiele to secure and enforce the rights granted to Thiele under this Assignment.
