## **NOTICE OF SECURITY INTEREST IN TRADEMARKS**

THIS NOTICE OF SECURITY INTEREST IN TRADEMARKS is made the 27th day of February, 2007 by and between ASSOCIATED BANK, NATIONAL ASSOCIATION, a national banking association (the "Secured Party"), and KOLPIN POWERSPORTS, INC., a Wisconsin corporation (the "Borrower").

The Borrower and the Secured Party acknowledge the following:

A. The Secured Party has made loans and other extensions of credit to the Borrower and Kolpin Outdoors, Inc. ("Outdoors") pursuant to that certain Demand Note No. 1, dated the date hereof, issued by the Borrower and Outdoors in the original principal amount of \$7,797,966.40 and payable to the order of the Secured Party ("Demand Note No. 1"), and that certain Demand Note No. 2, dated the date hereof, issued by the Borrower and Outdoors in the original principal amount of \$415,270.09 and payable to the order of the Secured Party ("Demand Note No. 2").

B. In connection with the transactions contemplated by Demand Note No. 1 and Demand Note No. 2, the Borrower has executed a Security Agreement to and for the benefit of the Secured Party, dated as of the date hereof (the "Security Agreement").


