**CERTIFICATE OF MERGER OF
NEHDC, INC. an Oregon corporation, and
WM, INC., an Oregon corporation,
with and into
WELLMED, INC., a Delaware corporation**

The undersigned corporation organized and existing under the Delaware General Corporation Law, does hereby certify that:

FIRST: The name and state of incorporation of each of the constituent corporations of the merger are as follows:

SECOND: An Agreement and Plan of Merger dated as of December 27, 2000, by and among WellMed, Inc., a Delaware corporation, NEHDC, Inc., an Oregon corporation, and WM, Inc., an Oregon corporation, (the "Merger Agreement") has been approved, adopted, certified, executed and acknowledged by WellMed, Inc., a Delaware corporation, NEHDC, Inc., an Oregon corporation, and WM, Inc., an Oregon corporation, in accordance with the requirements of Section 252 of the Delaware General Corporation Law.

THIRD: That the surviving corporation of the merger is WellMed, Inc., a Delaware corporation.

FOURTH: The Certificate of Incorporation of WellMed, Inc., a Delaware corporation, shall be the Certificate of Incorporation of the surviving corporation.

FIFTH: That the executed Agreement and Plan of Merger is on file at the principal place of business of the surviving corporation, a copy of which will be furnished, on request and without charge, to any stockholder of any constituent corporation. The address of the principal place of business of the surviving corporation is 520 N.W. Davis, Suite 300, Portland, Oregon 97209.

SIXTH: NEHDC, Inc. has authorized capital stock of 10,000,000 shares, all of which are designated "Common Stock", no par value. WM, Inc. has authorized capital stock of 6,000,000 shares, of which 5,000,000 are designated "Common Stock", no par value, and of which 1,000,000 are designated "Preferred Stock", no par value.
