RESOLVED, that Article First of the Corporation's Certificate of Incorporation shall be amended in its entirety to read as follows:

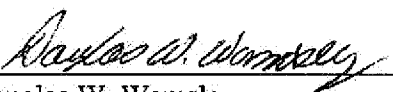
FIRST: The name of the corporation is WebMD Health Services Group, Inc.
