Pursuant to the provisions of Article 5.18 of the Texas Business Corporation Act (the "Act"), the undersigned, FLOW AUTOMATION INC, a Texas corporation, adopts the following Articles of Conversion for the purpose of converting, into THERMO PROCESS INSTRUMENTS, L.P., a Texas limited partnership, and hereby certifies as follows

FIRST Flow Automation Inc (the "Converting Entity") is a business corporation formed under the laws of the state of Texas
