DECLARATION OF BARBARA VINING

I, BARBARA VINING, declare as follows:

1. I am employed as an Attorney by Weil, Gotshal & Manges LLP. I make this declaration to summarize the correct and true chain of title for the following mark "KTAB," Registration No. 1482715, Registration Date 03/29/1988. Except as otherwise stated, I have knowledge of the facts set forth herein based on my research through the United States Patent and Trade Office.
2. The application for the following mark "KTAB" was filed on 08/11/1987 by Shamrock Broadcasting, Inc. and was registered on 03/29/1988. Assignor Shamrock Broadcasting, Inc. assigned the entire interest and the goodwill to Shamrock Holdings, Inc. on 03/25/1994. The Attorney of Record is Linda G. Morrison of Leventhal, Senter & Lerman.

The previously recorded assignment, recorded at reel/frame 3742/0614, dated 03/14/2008, was submitted in error, having included incorrect information on the accompanying schedules against which the assignment was recorded, and should not be considered to alter the true chain of title to the mark "KTAB" as indicated above.
