12 FEBRUARY

2007

**BETWEEN**

- (1) DBA Lux 1 SARL, a company governed by the laws of Luxembourg, having its registered office at L-2220 Luxembourg, 560 A, rue de Neudorf, Grand Duchy of Luxembourg ("**Assignor**");
- (2) DBAPPAREL (UK) LIMITED, a registered in England with registered number 0552438, whose registered office is at Britannia Wharf, Monument Road, Woking, Surrey GU21 5LW ("**the Assignee**"); and

**BACKGROUND**

- (A) The Assignor is or will become the registered proprietor of the registered trade marks detailed in **Schedule 1 ("the Registered Trade Marks")** and the applications to register the trade marks detailed in **Schedule 2 ("the Registered Trade Mark Applications")**;
- (B) On the date of this Deed, the parties entered into an assignment of intellectual property rights relating to the businesses of Gossard and Berlei carried on by DBApparel (UK) Limited ("**the Agreement**"). Under the Agreement, the Assignor agreed to assign the Registered Trade Marks and the Registered Trade Mark Applications (collectively called "**the Trade Marks**") to the Assignee; and
- (C) The Schedules to this Deed form part of the Deed and have the same force and effect as if set out in the body of the Deed and any reference to the Deed will include the Schedules.

**OPERATIVE PROVISIONS**

**1. ASSIGNMENT**

- 1.1 Pursuant to the terms of the Agreement, the Assignor assigns to the Assignee absolutely and free from all encumbrances the Trade Marks together with all the Assignor's rights and interests in respect of them and in respect of the right to sue for past infringements and the right to retain any damages or other benefit as a result of such action.
- 1.2 The Assignor agrees to execute such further documents, and take such actions and do such things, as may be reasonably requested by the Assignee to give full effect to the terms of this Deed and to secure the full right, title and interest of the Assignee in the Trade Marks.

**2. MISCELLANEOUS**

- 2.1 This Deed and all representations, obligations and warranties contained in it shall enure for the benefit of the successors and assignees of the parties.
- 2.2 The parties to this Deed do not intend that any of its terms will be enforceable by virtue of the Contracts (Rights of Third Parties) Act 1999 by any person not a party to it.
- 2.3 The formation, existence, construction, performance, validity and all aspects whatsoever of this Deed or of any term of this Deed will be governed by the law of England and Wales.
- 2.4 The courts of England and Wales will have exclusive jurisdiction to settle any disputes that may arise out of or in connection with this Deed. The parties irrevocably agree to submit to that jurisdiction except that each party may seek injunctive relief in any court of competent jurisdiction.

This document has been executed and delivered as a deed on the date stated at the beginning of this document.




