Be it known that for and in consideration of the sum of US\$1.00 to it in hand paid by the ASSIGNEE, and other good and valuable consideration, the receipt of which is hereby acknowledged, ASSIGNOR has sold, assigned, transferred and set over, and does hereby sell, assign, transfer and set out over unto ASSIGNEE, its successors, assigns and legal representatives, the full and exclusive right, title and interest for the territory of the United States of America in and to the said Trade Mark identified herein, together with the goodwill of the business associated therewith, the same to be held and enjoyed by ASSIGNEE for its own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by ASSIGNOR, as if this assignment and sale had not been made, together with any and all claims and demands, both at law and in

equity, which ASSIGNOR have or may have by reason of past infringement of said Trade Mark herein sold, assigned and transferred all rights to sue and recover for said claims and demands

AND ASSIGNOR hereby covenant that it has the full right to convey the entire right, title and interest herein assigned and it has not executed any agreement or assignment in conflict therewith


