**RELEASE OF SECURITY INTEREST, TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST** is effective the 15th day of April, 2008 by Wells Fargo Bank, N.A., a Delaware National Banking Association, with a business address of Sixth Street and Marquette Avenue, Minneapolis, MN 55479 ("Wells Fargo").

**WITNESSETH**

**WHEREAS**, Wells Fargo, in an GRANT OF SECURITY INTEREST dated as of May 23, 2007 ("Security Agreement") and recorded in the Assignment Branch of the U.S. Patent & Trademark Office at Reel 3549, Frame 0017, acquired a security interest from Adam Aircraft Industries, Inc., a Delaware corporation ("Adam Aircraft"), in the trademarks and applications for trademarks listed in the schedule attached hereto as Schedule A ("Trademarks");

WHEREAS, pursuant to the Findings of Fact, Conclusions of Law, and Order Under 11 U.S.C. §§ 105, 363 and 365 Authorizing and Approving the (I) Sale of Substantially All Assets Free and Clear of Liens, Claims, Interests and Encumbrances Pursuant to the Terms of the Asset Purchase Agreement Between the Trustee and AAI Acquisition, Inc. and (II) Assumption and Assignment of Certain Executory Contracts and Unexpired Leases in Connection With the Sale (the "Sale Approval Order") entered on April 9, 2008, by the United States Bankruptcy Court for the District of Colorado (the "Bankruptcy Court") in Case No. 08-11751-MER, the Bankruptcy Court authorized and directed the transfer of certain assets, including the Trademarks, to AAI Acquisition, Inc. free and clear of all liens and claims;

**NOW, THEREFORE**, in exchange for good and valuable consideration, receipt of which is hereby acknowledged, Wells Fargo hereby releases, waives, resigns and disclaims any and all security interests and related UCC financing statements in any of the Trademarks and in any other intellectual property and other collateral granted pursuant to the Security Agreement and/or any other documents, with all such security interests being transferred, affixed and attached to the proceeds of the sale of such collateral, as provided in paragraph 10 of the Sale Approval Order.
