CERTIFICATE OF AMENDMENT TO
AMENDED AND RESTATED
CERTIFICATE OF INCORPORATION
OF
HISPANIC MEDIA, INC.

Pursuant to the Delaware General Corporation Law (the "DGCL"), the Amended and Restated Certificate of Incorporation of **HISPANIC MEDIA, INC.**, a Delaware corporation, is amended as follows:

1. **Paragraph 1** of the Amended and Restated Certificate of Incorporation of Hispanic Media, Inc. is hereby deleted in its entirety and replaced with the following paragraph 1:

1. The name of the corporation shall be **Batanga, Inc.** (the "Corporation")

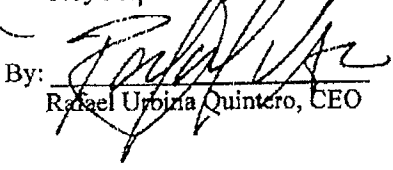

2. Except as provided for above, the Amended and Restated Certificate of Incorporation of the Corporation, as amended, shall remain unchanged.

On May 2, 2006, the Board of Directors of the Corporation approved such change to the Amended and Restated Certificate of Incorporation and recommended such amendment to the stockholders of the Corporation. Pursuant to Sections 228 and 242 of the DGCL, the amendment was approved by written consent of a majority of the stockholders of the Corporation effective on September 21, 2006. The number of votes cast in favor of the amendment by the stockholders was sufficient to approve the amendment.
