NUNC PRO TUNC ASSIGNMENT


WHEREAS, Sunriver Resort Limited Partnership, an Oregon corporation with its principal place of business at 11777 San Vicente Boulevard, Suite 900, Los Angeles, California 90049 ("Sunriver Resort"), is the owner of U.S. trademark registration number 1,511,033, for SUNRIVER RESORT and design; and

WHEREAS, on June 17, 1998, the United States Patent and Trademark Office recorded at REEL/FRAME 1744/0067 a Corrective Assignment to Correct the Receiving Party Name Previously recorded at REEL/FRAME 1479/0108-0147 from General Electric Capital Corporation to Pfaltzgraff Investment Company ("Pfaltzgraff Investment Co.") against U.S. trademark registration number 1,511,033; and
