TRADE MARKS ASSIGNMENT

THIS ASSIGNMENT is made the 2nd day of July 2007

BETWEEN

- b) The Assignor shall do or procure to be done all such further acts and things and execute or procure the execution of all such other documents as the Assignee may from time to time reasonably require in order to give the Assignee the full benefit of this agreement, whether in connection with any registration of title or other similar right or otherwise.
