Actions Required within the Next Six (6) Months:

1. With respect to the pending application for FLAVORMAX (TM Application Serial No. 77/069,728), the US Seller filed a Statement of Use, and it received back from the USPTO an Office Action on January 24, 2008, requiring the US Seller to submit a new specimen. The US Seller has responded to the Office Action and included a new specimen, together with a statement that the substitute specimen was in use in commerce prior to the expiration of the time allowed for filing a Statement of Use. The US Seller is currently awaiting notification from the USPTO that the application will now issue to registration.
2. With respect to FLAVORGUARD (TM Registration No. 2,179,916, a combined declaration of use in commerce/application for renewal of registration of the mark under sections 8 and 9 of the application will need to be filed on or before August 11, 2008 to renew this registration.
