TRADEMARK ASSIGNMENT AGREEMENT

This Agreement entered into in Montreal, province of Quebec, on this 1st day of March 2008.

BY AND BETWEEN

MANSTER MEDIA GROUP INC. a corporation duly incorporated under the laws of Florida, having its head office at 7480 Ridgefield Lane, Lakeworth, Florida, 33467, United States

(Hereinafter referred to as "Assignor")

AND:

MANSEF PRODUCTIONS INC., a corporation duly incorporated under the laws of Canada, having its head office at 9001 L'Acadie Boulevard, Suite 701, Montreal Quebec H4N 3H5

(Hereinafter referred to as "Assignee")

WHEREAS on November 28, 2008 and February 4, 2008 the Assignor filed with the United States Patent and Trademark Office a trademark for BRAZZERS, said trademark bears the serial numbers 7339083 and 77387833 (the "Assigned Trademarks");

WHEREAS, Assignee desires to acquire all Assignor's right, title and interest in and to the Assigned Trademark;

WHEREAS Assignor desires to transfer, convey and assign in favor of Assignee all it's rights, titles and interests in and to the Assigned Trademarks; and

WHEREAS, Assignee is the principal worldwide owner with respect to the Business, to which trademarks pertain, and the Business is ongoing and existing;

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained in this agreement, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee agree as follows:


1. Assignment of Trademark. Effective as of March 1, 2008, Assignor transfers, conveys, assigns and delivers to Assignee and Assignee accepts all right, title and interest of Assignor in and to (i) the Assigned Trademark , (ii) the registrations

and applications for registrations thereof and (iii) the goodwill of the business connected with the use thereof and symbolized thereby.

2. Successors. This Assignment shall inure to the benefit of and is binding upon the respective successors and assigns of Assignor and Assignee.
3. Dispute Resolution. Any dispute as to the rights assigned pursuant to this Assignment shall be resolved in accordance with the laws of Quebec.
4. The parties agree that the present agreement be drawn up in English. *Les parties conviennent que cette convention soit rédigée en anglais.*

IN WITNESS WHEREOF, Assignor and Assignee caused this Assignment to be duly executed as of the date first written above.


