TRADEMARK ASSIGNMENT

1. For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby transfers and assigns to Assignee all right, title, and interest, worldwide, in and to the marks listed in Schedule A (the "Marks"), together with the goodwill of the business associated therewith, including, but not limited to: (a) any and all registrations and applications for registration of the Marks; (b) any and all common law and statutory rights, title, privileges and interests of Assignor in and to the Marks; (c) any and all income, royalties, damages and payments now or hereafter due and/or payable with respect thereto, including without limitation claims for damages that Assignor has asserted or is entitled to assert against any third party for past infringement or other misuse of the Marks, including the right to collect such damages and to sue for infringement or other misuse of the Marks; and (d) all rights and authority to file in Assignee's own name applications for trademark and service mark registration in connection with the Marks, and to secure in its own name the registrations granted thereon, and to file opposition and cancellation proceedings to enforce and protect the Marks.

2. Assignor shall execute and deliver, from time to time, all further instruments of conveyance and assignment and perform all such other acts, as may be reasonably required to transfer and assign to Assignee all of Assignor's rights in and to the Marks and/or to record such assignment with the appropriate governmental agency.


3. This Assignment shall become effective for all purposes as of the Effective Date and shall be governed by and interpreted under the laws of the State of California.
