NOTICE OF SATISFACTION OF TRADEMARK SECURITY AGREEMENT

This **NOTICE OF SATISFACTION OF TRADEMARK SECURITY AGREEMENT** (this "Notice") dated as of April 17, 2008 is given by WACHOVIA BANK, NATIONAL ASSOCIATION, as Administrative Agent (in such capacity, the "Administrative Agent") for the ratable benefit of the banks and other financial institutions (the "Lenders") from time to time parties to the Amended and Restated Loan Agreement dated as of March 30, 2006 (as amended, restated, supplemented or otherwise modified from time to time, the "Loan Agreement") by and among EDGE WIRELESS, LLC (formerly known as NewCom Wireless, LLC), an Oregon limited liability company, as borrower (the "Grantor"), the Lenders party thereto and Wachovia Bank, National Association, as Administrative Agent.

Pursuant to the terms of that certain Trademark Security Agreement dated as of March 30, 2006 (as amended, restated, supplemented or otherwise modified, the "Trademark Security Agreement"), the Grantor granted to the Administrative Agent a continuing security interest in all of Grantor's right, title, and interest in, to and under the Trademark Collateral (as such term is defined in the Trademark Security Agreement), including without limitation that certain trademark registration and trademark license described on Schedule A hereto.

The Obligations (as defined in the Loan Agreement) have been satisfied in full and any security interest of Wachovia Bank, National Association, as Administrative Agent has been terminated (including, without limitation, the security interests, duly recorded on April 26, 2006 at Reel 3297, Frame 0124 in the United States Patent and Trademark Office).
