## CONFIRMATION OF TERMINATION OF SECURITY INTEREST IN TRADEMARKS

On November 17, 1998, A Different Light, Inc., a Delaware corporation (which changed its name to Illuminations.com, Inc.), located at 1736 Corporate Circle, Petaluma, California 94964 USA, granted a Security Interest to BankBoston Retail Finance Inc. (n/k/a Fleet Retail Finance Inc.), a Massachusetts corporation, located at 40 Broad Street, Boston, Massachusetts 02109, in certain trademarks as recorded in the United States Patent and Trademark Office on November 25, 1998 at Reel 1821 and Frame 0499 and on March 16, 1999 at Reel 1871 and Frame 0448.

On April 8, 1999, A Different Light, Inc. changed its name to Illuminations.com, Inc. as recorded in the United States Patent and Trademark Office on July 14, 1999 at Reel 1929 and Frame 0213.

On March 7, 2000, Illuminations.com, Inc. (f/k/a A Different Light, Inc.), a Delaware corporation, granted a Security Interest to Fleet Retail Finance Inc. (f/k/a BankBoston Retail Finance Inc.), a Delaware corporation, located at 40 Broad Street, Boston, Massachusetts 02109, in certain trademarks as recorded in the United States Patent and Trademark Office on September 27, 2000 at Reel 2164 and Frame 0680.

On March 9, 2004 and May 14, 2004, the two aforementioned Security Interests granted by Illuminations.com, Inc. (f/k/a A Different Light, Inc.) to Fleet Retail Group Inc. (f/k/a Fleet Retail Finance Inc.) and to BankBoston Retail Finance Inc. (n/k/a Fleet Retail Finance Inc.) were assigned to Madeleine, L.L.C. respectively as recorded in United States Patent and Trademark Office on May 19, 2004 at Reel 2857 and Frame 0114.

On May 1, 2004, Illuminations.com, Inc. (f/k/a A Different Light, Inc.) assigned its trademarks to Candle Acquisition Co. as recorded in the United States Patent and Trademark Office on June 7, 2004 at Reel 2988 and Frame 0330 and on June 23, 2004 at Reel 2878 and Frame 0222.

On July 25, 2006, Madeleine, L.L.C., a New York limited liability company, having a place of business at 450 Park Avenue, 28<sup>th</sup> Floor, New York, New York 10022 (the "Secured Party") reassigned its interest in all intellectual property of Candle Acquisition Co., including without limitations the trademarks ILLUME and ILLUMINATIONS, to Candle Acquisition Co. (which was acquired by The Yankee Candle Company, Inc.). Madeleine, L.L.C. hereby confirms, effective July 25, 2006, that Candle Acquisition Co. has or has caused to be paid and satisfied in full certain obligations for which the security interest in the Trademarks was granted and it also had released its security interest in the Trademarks listed in Exhibit A attached hereto.

On July 25, 2006, Candle Acquisition Co. assigned its trademarks to The Yankee Candle Company, Inc. as recorded in the United States Patent and Trademark Office on October 26, 2006 at Reel 3416 and Frame 0837.

Madeleine, L.L.C. further agrees, for itself, its successors and assigns, to execute such further documents and to perform such further lawful acts as may reasonably be requested by The Yankee Candle Company, Inc. to effectuate this termination.
