## TERMINATION AND REASSIGNMENT

This **TERMINATION AND REASSIGNMENT** terminating the Collateral Assignment of Patents, Trademarks, Copyrights and Licenses dated as of October 29, 2002 (the "**Collateral Assignment**") by **Cooper Instrument Corporation**\* ("Cooper") and **Atkins Technologies, Inc.** ("Atkins") to the **Connecticut Development Authority**, and reassigning any right, title and interest assigned or granted by the Collateral Assignment, is made this 17th day of April, 2008 by the Connecticut Development Authority (the "**CDA**"), a body politic and corporate constituting a public instrumentality and political subdivision of the State of Connecticut, having its principal office at 999 West Street, Rocky Hill, Connecticut.

\*n/k/a Cooper-Atkins Corporation      WITNESSETH:

**WHEREAS**, on October 29, 2002, Cooper and the CDA entered into a Loan Agreement pursuant to which the CDA had made a certain Loan (as defined in the Loan Agreement) to Cooper, the repayment of which Loan was unconditionally guaranteed by Atkins; and

**WHEREAS**, Cooper and Atkins granted the Collateral Assignment to the CDA to secure the repayment of the Loan to the CDA, which Collateral Assignment was recorded in the United States Patent and Trademark Office ("USPTO") on Reel 2704 at Frame 283; and

**WHEREAS**, the Loan has been paid in full and the CDA is thereby required to execute this Termination and Reassignment.

NOW THEREFORE, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which hereby acknowledged by the CDA, the CDA hereby agrees as follows:

1. The Collateral Assignment is fully and forever terminated and extinguished, including the Collateral Assignment as recorded in the USPTO.
2. The CDA hereby reassigns all right, title and interest to Cooper and Atkins which were assigned, granted or conveyed to the CDA from Cooper and Atkins by the Collateral Assignment, and also including any and all right, title and interest in the (A) patents and patent applications set forth on Schedule A of the Collateral Assignment, also attached hereto as Schedule A, (B) trademarks, service marks and copyrights set forth on Schedule B of the Collateral Assignment, also attached hereto as Schedule A, and (C) licenses set forth on Schedule C of the Collateral Assignment, also attached hereto as Schedule C.
3. All duties or other obligations of the CDA under the Collateral Assignment are hereby terminated.
4. The CDA warrants that it has the unqualified right to enter into this Termination and Reassignment and to release Cooper and Atkins in accordance with the terms herein.
