**TRADEMARK AND DOMAIN NAME ASSIGNMENT**

This TRADEMARK AND DOMAIN NAME ASSIGNMENT (the "**Trademark and Domain Name Assignment**") made and entered into as of April 1, 2008, by and among Macrovision Corporation, a Delaware corporation ("**Assignor**"), Acreso Software Inc., a Delaware corporation ("**Acreso**"), and InstallShield Co Inc., a Delaware corporation ("**InstallShield**"). Each of Acreso and InstallShield is referred to herein as "**Assignee**" with respect to the Marks (as defined below) for which Acreso or InstallShield, respectively, is identified as the Assignee on Exhibit A hereto and with respect to the Domain Names (as defined below) for which Acreso or InstallShield, respectively, is identified as the Assignee on Exhibit B hereto. Assignor and Assignee are referred to individually as a "Party" and collectively as the "**Parties**."

**RECITALS**

A. Assignor and Acreso are parties to that certain Asset Purchase Agreement dated as of February 13, 2008 (the "**Purchase Agreement**"). All capitalized terms used in this Trademark and Domain Name Assignment but not otherwise defined herein shall have the meanings ascribed to them in the Purchase Agreement.

B. Pursuant to the Purchase Agreement, Assignor agreed to sell, convey, assign, transfer, and deliver to Assignee, and Assignee agreed to purchase and acquire from Assignor, all right, title and interest in and to the Business Assets, including but not limited to trademarks and trademark rights listed on Exhibit A hereto, any registrations and applications therefor, any renewals and extensions of the registrations, and all other corresponding rights that are or may be secured under the laws of the United States or any foreign country, together with the goodwill of the business associated therewith (collectively, the "**Marks**") and domain names listed on Exhibit B hereto (collectively, the "**Domain Names**").

C. Assignee desires to acquire all of the Marks and the Domain Names.

**NOW THEREFORE**, in consideration of the covenants and mutual agreements set forth in this Trademark and Domain Name Assignment and in the Purchase Agreement and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee agree as follows:

1. Assignor hereby irrevocably sells, grants, conveys, assigns and sets over to Assignee, its successors and assigns, without any reservation of rights, all of its right, title and interest in and to the Marks in the world for all of the goods and/or services included in the relevant applications or registrations or in conjunction with which the Marks are used, together with the goodwill of the business associated with and symbolized by the Marks for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by

Assignor if this Trademark and Domain Name Assignment had not been made, together with all income, royalties or payments due or payable as of the Closing Date or thereafter, including, without limitation, the right of the Assignee to bring actions, claim relief, and claim damages in respect of any past, present or future infringement, unauthorized use or other violation of rights with respect to any of the Marks throughout the world, together with the goodwill of the business associated therewith; including any and all common law rights, applications, and registrations for the Marks.

2. Assignor hereby irrevocably sells, grants, conveys, assigns and sets over to Assignee, its successors and assigns, without any reservation of rights, all of its right, title and interest in and to the Domain Names in the world.

3. Assignor agrees to execute and deliver at the reasonable request of Assignee, without demanding any further consideration, all papers, instruments, and assignments, and to perform other reasonable acts Assignee may reasonably request in order to vest all right, title, and interest in and to the Marks and Domain Names over to Assignee, to perfect and enforce its right, title and interest in and to the Marks and Domain Names and/or to provide evidence to support any of the foregoing in the event such evidence is deemed reasonably necessary by Assignee, to the extent such evidence is in the possession or control of Assignor.

4. Assignor hereby (a) requests the Commissioner of Patents and Trademarks of the United States of America, and the corresponding entities or agencies in any applicable foreign countries, to record Assignee as the assignee and owner of the Marks, and (b) requests the respective domain name registrars for the Domain Names to record Assignee as the registrant of the Domain Names.

5. The terms and conditions of this Trademark and Domain Name Assignment will inure to the benefit of Assignee, its successors, assigns, and other legal representatives, and shall be binding upon Assignor, its successor, assigns, and other legal representatives.

6. This Trademark and Domain Name Assignment expressly supersedes and replaces any prior assignment executed by Assignor in favor of Assignee with respect to the Marks and Domain Names.

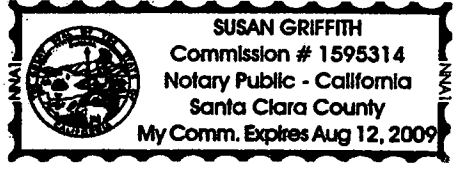
