**TERMINATION AND RELEASE  
OF COLLATERAL ASSIGNMENT OF TRADEMARKS**

This Termination and Release of Collateral Assignment of Trademarks ("Termination and Release") is granted this 13<sup>th</sup> day of March 2008, by Wilmington Trust Company, as Collateral Agent (the "Collateral Agent") in favor of The Goodyear Tire & Rubber Company ("Goodyear") pursuant to the Collateral Agreement, dated as of March 12, 2004 (the "Collateral Agreement"), by and among Goodyear, the Subsidiaries of Goodyear identified as Grantors therein ("Goodyear Subsidiaries"), and the Collateral Agent. Capitalized terms used in this Termination and Release not otherwise defined shall have the meanings given to such terms in the Collateral Agreement.


WHEREAS, the Collateral Agent, holds, for the benefit of the Secured Parties, a security interest in certain intellectual property assets of Goodyear, including but not limited to the U.S. trademark registrations and applications listed on Schedule I attached hereto (the "Trademarks") pursuant to the Collateral Agreement and recorded with the U.S. Patent and Trademark Office on April 26, 2004, at Reel 2954, Frame 0793 against such Trademarks;

WHEREAS, Goodyear and the Goodyear Subsidiaries have satisfied all of their obligations to the Secured Parties and to the Collateral Agent for the Secured Parties, under the Note Obligations, the Designated Pari Passu Obligations and the Collateral Agent Obligations, and Goodyear is desirous of recording this instrument to confirm and evidence termination and release of the security interests held by the Collateral Agent in the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacies of which the parties hereby acknowledge, the Collateral Agent for the Secured Parties, as directed by the Trustee, hereby unconditionally, irrevocably and absolutely terminates, releases, extinguishes and forever discharges its security interest in the Trademarks, together with the goodwill of the business associated with and symbolized thereby. This Termination and Release shall be binding upon the Collateral Agent's legal representatives, assigns and successors and upon the Secured Parties. The Collateral Agent hereby authorizes, and requests that, the Director of the United States Patent and Trademark Office or his delegate to record this Termination and Release against the Trademarks.

IN WITNESS WHEREOF, the Collateral Agent, by its duly authorized officer, has executed this Termination and Release as of March 13, 2008.
