I, Donna Laton Armstrong the undersigned officer of Coats & Clark, Inc., a Delaware corporation, declare that:


On December 4, 1979, Armour-Dial, Inc., a Delaware corporation, assigned the assets relating to its yarn and other needlecraft business including the trademarks and the goodwill associated therewith (the "Trademarks"), to Armour Handcrafts, Inc., an Arizona corporation; that one such Trademark, CONFETTI, is the subject of U.S. Registration No. 351,662; that the Assignment which was recorded in the U.S. Patent and Trademark Office on February 8, 1980, Reel 0364, Frames 233-242, inadvertently failed to identify Reg. No. 351,662 for the mark CONFETTI when it was originally prepared; that Armour-Dial, Inc. and Armour Handcrafts, Inc. no longer exist as active entities; that the Trademarks, including the CONFETTI mark, were thereafter assigned by Armour Handcrafts, Inc. to Bucilla Corporation, and thereafter to Coats & Clark, Inc. pursuant to assignment documentation recorded with the U.S. Patent and Trademark Office; that Registrant respectfully submits the following information to establish the chain of title of the mark CONFETTI to Coats & Clark, Inc., correct and current owner of U.S. Trademark Registration No. 351,662; and that I am an officer of Registrant, I am involved in the every day business of Coats & Clark, Inc. and its trademark matters.
