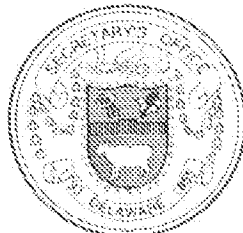

RESOLVED that this Corporation shall cause to be executed and filed and/or

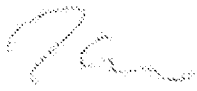
