RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "**Release**") is made as of April 1, 2008, by BMO GLOBAL CAPITAL SOLUTIONS, INC., AS ADMINISTRATIVE AGENT, a Delaware corporation ("**BMO**"), in favor of NATIONAL COMPUTER PRINT, INC., an Alabama corporation ("**Borrower**").

WITNESSETH:

WHEREAS, in connection with certain loans and financial accommodations extended from BMO to Borrower (the "**Loans**"), Borrower granted a security interest in certain of its trademarks and service marks as set forth on Schedule A hereto (collectively, the "**Trademark Collateral**") to BMO to secure the Loans;

WHEREAS, the Loans were refinanced by another lender and all obligations due and owing by Borrower to BMO were paid to BMO in full on or around April 1, 2008;

WHEREAS, Borrower has requested that BMO (a) terminate and release the liens and interests of BMO in the Trademark Collateral, and (b) execute and deliver evidence of such termination and release for filing in the United States Patent and Trademark Office; and

WHEREAS, BMO has agreed to such release and termination;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, BMO hereby releases and terminates its security interests in and to the Trademark Collateral, and reassigns to Borrower all right, title and interest of BMO in and to the Trademark Collateral.

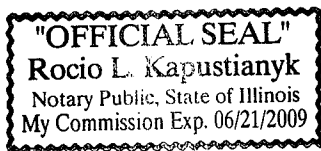
