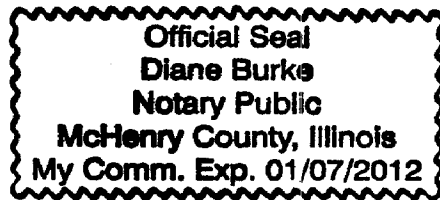
WHEREAS, Assignor wishes to assign all its right, title and interest in the registered trademark OPTIONMED, Reg. No. 2,576,648, to Assignee.
