NOTICE OF RELEASE OF SECURITY INTEREST

WHEREAS, ELCOM OF VIRGINIA, INC. (the “Elcom Pledgor”) is the owner of the trademarks and service marks listed on Schedule A attached to this Notice of Release of Security Interest (this “Notice”), which marks are registered or have pending registrations in the United States Patent and Trademark Office as set forth on Schedule A attached hereto (the “Elcom Trademarks”); and

WHEREAS, the Elcom Pledgor, KSLA, LLC, KTVO License Subsidiary, Inc., Raycom America, Inc. and WSTM License Subsidiary, Inc. (collectively, the “Pledgors”) entered into a Security Agreement (as amended, modified, restated or supplemented from time to time, the “Security Agreement”), dated as of October 6, 2004, wherein the Pledgors agreed to execute and thereafter did execute an Assignment and Grant of Security Interest (the “Assignment”) with WACHOVIA BANK, NATIONAL ASSOCIATION, as Administrative Agent (the “Administrative Agent”), whereby the Pledgors assigned and granted to the Administrative Agent a security interest in all of their right, title and interest in and to, the Elcom Trademarks and other trademarks and service marks owned by the Pledgors as set forth therein (all such trademarks, service marks, registrations and applications, collectively, the “Trademarks”), and the use thereof, together with all proceeds and products thereof and the goodwill of the businesses symbolized by the Trademarks; and


WHEREAS, the Assignment was duly recorded by the Assignment Division of the United States Patent and Trademark Office on October 11, 2004, at Reel 002953, Page 0621, in the office of same; and

WHEREAS, pursuant to the Release Agreement (the “Release”) entered into by the Administrative Agent and the Released Entities on the signature pages attached thereto, subject to the terms and conditions therein, and the Consent (the “Consent”), dated as of March 31, 2008, by and among Raycom TV Broadcasting, LLC, the Lenders party to the Credit Agreement referred to therein, and the Administrative Agent, the Elcom Pledgor has been granted a release from its obligations under the Security Agreement, and the security interests in the Elcom Trademarks granted to the Administrative Agent by the Assignment have been terminated;

NOW, THEREFORE, in conjunction with the Release and Consent, the Administrative Agent hereby releases the Elcom Pledgor and the Elcom Trademarks from the Assignment as recorded by the Assignment Division of the United States Patent and Trademark Office on October 11, 2004, at Reel 002953, Page 0621, and hereby seeks to have this Notice duly recorded in the office of same, with the Assignment otherwise remaining in full force and effect, for all other Pledgors and Trademarks set forth therein and subject thereto.
