## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

WHEREAS, by that certain Trademark Security Agreement dated October 26, 1994 ("First Security Agreement"), recorded in the Trademark Assignment database of the United States Patent and Trademark Office ("PTO") on February 27, 1995 at Reel/Frame 1302/0068, Personnel Management, Inc., an Indiana corporation with an address at 1499 Windhorst Way #220, Greenwood, Indiana 46143 ("PMI") granted to Society National Bank, Indiana, a national banking association ("Society"), a continuing security interest in all of PMI's right, title and interest in, to and under certain "Trademark Collateral" (as defined therein), including without limitation U.S. trademark registration No. 1,816,103 for PMI (Stylized) (the "Federal Registration");

WHEREAS, by that certain Assignment dated August 1, 1997, recorded in the Trademark Assignment database of the PTO on November 11, 1997 at Reel/Frame 1656/0517, PMI assigned to its affiliate PMI Holdings, Inc., a Delaware corporation with an address at 1499 Windhorst Way #220, Greenwood, Indiana 46143 ("Holdings"), all of its right, title and interest in and to the Federal Registration;

WHEREAS, by that certain Trademark Security Agreement dated August 1, 1997 ("Second Security Agreement"), recorded in the Trademark Assignment database of the PTO on November 17, 1997 at Reel/Frame 1659/0757, Holdings granted to KeyBank National Association, a national banking association and a successor to Society, with an address at 900 Market Tower, 10 West Market Street, Indianapolis, Indiana 46204 ("KeyBank"), a continuing security interest in all of its right, title and interest in, to and under the "Trademark Collateral" (as defined therein), including without limitation the trademark registrations set forth in Schedule A;

WHEREAS, Releasor wishes to provide a document suitable for recording in the Trademark Assignment Database of the PTO for purposes of recording the release, relinquishment and discharge of its security interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby relinquishes, releases and discharges (a) the security interest in the Trademark Collateral (as defined in the First Security Agreement) granted by PMI in the First Security Agreement; and (b) the security interest in the Trademark Collateral as defined in the Second Security Agreement granted by Holdings in the Second Security Agreement.


