CONFIRMATORY ASSIGNMENT OF TRADEMARK SECURITY AGREEMENT

This CONFIRMATORY ASSIGNMENT OF TRADEMARK SECURITY AGREEMENT (this "Confirmatory Assignment") is executed as of March 14, 2008 by Wells Fargo Financial Corporation Canada, a Nova Scotia unlimited liability company, having its place of business at 55 Standish Court, Suite 400, Mississauga, Ontario L5R 4J4 (the "Assignor"), in favor of Geosam Investments Limited, a Nova Scotia limited company, having its place of business at 6009 Quinpool Road, 10th Floor, Halifax, Nova Scotia, B3K 5J7 (in such capacity, "Assignee").

WHEREAS, the Assignor and Consoltex Inc. ("Consoltex") are among the parties to a credit agreement dated April 21, 2006 (as the same may be amended, supplemented or otherwise modified or restated from time to time, the "Credit Agreement"), to a general security agreement, dated April 21, 2006 (as the same may be amended, supplemented or otherwise modified or restated from time to time, the "Security Agreement") and to a trade-mark security agreement dated April 21, 2006 (as the same may be amended, supplemented or otherwise modified or restated from time to time, the "Trade-Mark Security Agreement");

WHEREAS, pursuant to the Security Agreement and the Trade-Mark Security Agreement, Consoltex has granted in favour of the Assignor, a continuing security interest in all of Consoltex's right, title and interest in and to the Intellectual Property (as defined in the Security Agreement), including (i) all of its trade-marks and trade-mark licenses to which it is a party including those United States trade-mark applications and registrations referred to in Schedule 1 annexed hereto; (ii) all reissues, continuations or extensions of the foregoing; (iii) all goodwill of the business connected with the use of, and symbolized by each trade-mark and each trade-mark license; and (iv) all products and proceeds of the foregoing, including, without limitation, any claim by Consoltex against third parties for past, present or future infringement or dilution of any trade-mark or any trade-mark licensed under any intellectual property license or injury to the goodwill associated with any trade-mark or any trade-mark licensed under any intellectual property license (the "Security Interest");

WHEREAS, the Trade-Mark Security Agreement was recorded in the United States Patent and Trademark Office at Reel 3326, Frame 0660 on June 13, 2006 against the trade-mark applications and registrations initially covered in Schedule 1 to the Trade-Mark Security Agreement;

WHEREAS, on January 11, 2008, the Trade-Mark Security Agreement was recorded in the United States Patent and Trademark Office at Reel 3694, Frame 0290 against US trade-mark application Nos. 77/189,843, 77/189,795, 77/189,739, 77/054,506 and 77/054,489 in accordance with Section 4 of the Trade-Mark Security Agreement;

WHEREAS, Assignor and Assignee are parties to an assignment and acceptance agreement dated March 14, 2008 (the "Assignment Agreement") pursuant to which the Security Interest granted by Consoltex to the Assignor has been assigned by the Assignor to the Assignee; and


WHEREAS, the Assignee has requested that the Assignor execute this Confirmatory Assignment for the purpose of giving notice of the assignment of the Assignor's Security Interest to the Assignee pursuant to the Assignment Agreement.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby confirmed and agreed that:

1. Confirmatory Assignment. The Assignor hereby confirms that, pursuant to the Assignment Agreement, it has assigned to the Assignee the Security Interest.
2. Conflicts. Notwithstanding anything herein to the contrary, in the event of any conflict between the terms of the Assignment Agreement, and this Confirmatory Assignment, the terms of the Assignment Agreement shall govern.
