**RELEASE OF TRADEMARK SECURITY INTEREST**

WHEREAS, NORDCO INC., a Delaware corporation, having a place of business at 245 West Forest Hill Avenue, Oak Creek, Wisconsin 53154 (hereinafter "NORDCO") was previously obligated to GE Business Financial Services Inc., formerly known as Merrill Lynch Capital, a Division of Merrill Lynch Business Financial Services Inc., in its capacity as Agent for Lenders (hereinafter "GE BFSI") under the Amended and Restated Credit Agreement, dated as of September 8, 2006 (as amended, the "Credit Agreement"); and

WHEREAS, NORDCO executed a Trademark Security Agreement dated July 16, 2003, (hereinafter the "Trademark Security Agreement") in favor of GE BFSI covering the Trademark Collateral (as defined in the Trademark Security Agreement), including without limitation the trademarks listed in Schedule 1 attached hereto; and

WHEREAS, the Trademark Security Agreement was recorded in the Assignment Division of the United States Patent and Trademark Office on July 24, 2003, at reel/frame number 2689/0119; and

WHEREAS, NORDCO has satisfied its obligations to GE BFSI.


NOW THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Trademark Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, GE BFSI hereby states as follows:

1. Release. GE BFSI does hereby acknowledge that NORDCO has satisfied its obligations referenced herein and GE BFSI hereby releases all right, title, and interest in and to the Trademark Collateral, including without limitation the trademarks listed in Schedule 1 attached hereto, together with the goodwill of the business symbolized by the Trademark Collateral and the registration thereof, and all products and proceeds thereof, including without limitation, any and all causes of action which may exist by reason of infringement thereof.

2. Further Assurances. The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest in the Trademark Collateral contemplated hereby.

IN WITNESS WHEREOF, GE BFSI has caused this Termination and Release of Security Interest in Trademarks to be duly executed by its officer thereunto duly authorized as of the 29<sup>th</sup> day of April, 2008.



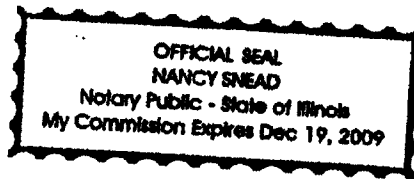
