TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of August 31, 2007, is made by American Capital Financial Services, Inc., as Agent (the "Secured Party").

WHEREAS, Seroyal USA, Inc. and Seroyal International Inc. (the "Grantors") have granted a security interest in certain personal property to the Secured Party, including without limitation a security interest in certain trademarks, trademark applications, and/or trademark licenses ("Trademarks");
