## **RELEASE OF TRADEMARK SECURITY INTEREST**

WHEREAS, TRM CORPORATION, an Oregon corporation (the "Borrower") has used and is using in its business the trademarks listed on Schedule 1 hereto (hereinafter the "Trademark Collateral") which have been registered in the United States Patent and Trademark Office;

WHEREAS, the Borrower was previously obligated to WELLS FARGO FOOTHILL, INC., a California Corporation ("Agent"), in its capacity as Administrative Agent for the Lenders under that certain Credit Agreement, dated June 6, 2006 (the "Credit Agreement"), and the Borrower executed that certain First Lien Trademark Security Agreement, dated June 6, 2006 (hereinafter the "Agreement") in favor of Agent;


WHEREAS, the Agreement was recorded in the records at the United States Patent and Trademark Office on June 8, 2006 at reel/frame number 003323/0808; and

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Agent hereby releases all right, title and interest in and to, and assigns to the Borrower the Trademark Collateral, together with the goodwill of the business symbolized by the Trademark Collateral and the registration thereof, and all proceeds and products thereof, including without limitation, any and all causes of action which may exist by reason of infringement thereof.

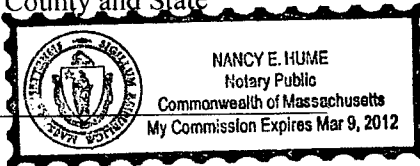
