ASSIGNMENT OF TRADEMARK

THIS ASSIGNMENT OF TRADEMARK (this "Assignment"), dated as of April 17, 2008 ("Effective Date"), is from MIDCOUNTRY BANK, a federal savings bank ("Assignor"), to MIDCOUNTRY FINANCIAL CORP., a Georgia corporation ("Assignee").

WITNESSETH:

WHEREAS, Assignor desires to assign to Assignee all right, title and interest in and to the trademark noted in the attached Exhibit A, MIDCOUNTRY BANK DEPOSIT DEPOSIT CHECKS FROM YOUR OFFICE & Design (the "Trademark"), together with any and all goodwill of the business associated with the Trademark; and

WHEREAS, Assignor inadvertently identified itself as a Minnesota corporation in the U.S. application for the Trademark and desires to make this assignment in the name of "MidCountry Bank, a Minnesota corporation" only to correlate with the information in the records of the U.S. Trademark Office for recording purposes, but will hereafter record a corrective assignment reflecting the proper chain of title;

WHEREAS, Assignee desires to acquire the Trademark and all goodwill of the business associated therewith from Assignor; and

WHEREAS, Assignor and Assignee desire to confirm of record the assignment of the Trademark to Assignee;

NOW, THEREFORE, for \$1.00 and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee hereby agree as follows:

1. Assignor hereby assigns to Assignee all right, title and interest in and to the Trademark, together with (i) the goodwill and the business symbolized by the Trademark and (ii) all causes of action, claims and demands and other rights for, or arising from, any infringement, including past infringements, of the Trademark.

2. Assignor further agrees without further consideration to cause to be performed such other lawful acts and to be executed such further assignments and other lawful documents as Assignee may from time to time reasonably request to effect fully this Assignment and to permit Assignee to be duly recorded as the registered owner of the Trademark and all other rights hereby conveyed.
