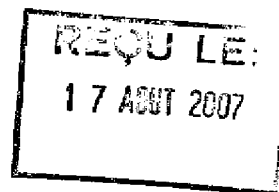

- that according to the terms registered at the Commercial registry office in Paris, the 17<sup>th</sup> July 1975, the registered head office of Tractel SA was transferred from 16 Place de la République, Paris to 85 – 87 rue Jean Lolive, Bagnole, (post code 93170).
- that according to the modified terms registered at the clerk's office of the commercial registry in Paris, the 12<sup>th</sup> December 1983, that according to the legal requirement published the 17<sup>th</sup> June 1974, the offices of Tractel SA were transferred from 85 – 87 rue Jean Lolive, Bagnole, (post code 93170) to 85 – 87 rue Jean Lolive, Montreuil sous Bois Bagnole, (post code 93100) without the offices moving.
